- 1) The City Government of Tanauan, through the General Fund intends to apply the sum of PHP 488,950.00 being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Latex Paint. Bid received in excess of the ABC Shall be automatically rejected at bid opening.
- 2) The City Government of Tanauan now invites bids for supply and delivery of Latex Paint of the prospective bidder of all its ongoing and completed government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid, within the relevant period. The description of an eligible bidder is contained in the Bidding Documents particularly in Section II. Instruction to Bidders.

3) Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the " Government Procurement Reform Act".

(i) Bidding is restricted to Filipino citizens/sole proprietorships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4) Interested bidders may obtain further information from the City Government of Tanauan and inspect the Bidding documents at the address given below during 8:00 am to 5:00 pm.

5) A complete set of Bidding documents may be purchased by interested bidders on April 27, 2018 from the address below and upon payment of a nonrefundable fee amounting to Five Hundred Pesos (Php500.00) for the Bidding Documents in the amount based on the amount of project cost.

6) The Pre-bid conference is on 2:00pm/ May 4, 2018 at BAC Office Boardroom which shall be open only to all interested parties who have purchased the Bidding Documents.

7) Bids must be delivered to the address below on or before 10:00am/ May 16, 2018
All bids must be accompanied by a bid security in any of acceptable forms in the amount.

2) Bank Guarantee two percent (2%)

3) Surety Bond five percent (5%)
