**Description**

1) The City Government of Tanauan, through the General Fund intends to apply the sum of **PHP 3,918,513.00 per month for (8) months** being the Approved Budget for the Contract(ABC) to payments under the contract for the **Garbage Hauling Services (8 months)**. Bid received in excess of the ABC Shall be automatically rejected at bid opening.

2. The City Government of Tanauan now invites bids for **Garbage Hauling Services (8 months)**. Statement of the prospective bidder of all its ongoing and completed government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid, within the relevant period. The description of an eligible bidder is contained in the Bidding Documents particularly in Section II. Instruction to Bidders.

		<b>Equipments</b> Shall have five (5) mini-dump trucks for narrow roads and six (6) dump trucks Shall have spare trucks in case of breakdown

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA ) 9184, otherwise known as the “ Government Procurement Reform Act”.

i) Bidding is restricted to Filipino citizens/sole proprietorships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4.) Interested bidders may obtain further information from the City Government of Tanauan and inspect the Bidding documents at the address given below during 8:00 am to 5:00 pm.

5.) A complete set of Bidding documents may be purchased by interested bidders on **March 8, 2018** from the address below and upon payment of a nonrefundable fee amounting to Twenty Five Thousand Pesos Only (**Php25,000.00**) for the Bidding Documents in the mount based on the amount of project cost.

6.) The Pre-bid conference is on 2:00pm/ **March 15, 2018** at BAC Office Conference Room which shall be open only to all interested parties who have purchased the Bidding Documents.

7.) Bids must be delivered to the address below on or before 10:00am/ **March 27, 2018**. All bids must be accompanied by a bid security in any of acceptable forms in the amount.

a) Form of Security Minimum Amount in % of Approved Budget for the Contract to be Bid.

- 1) Cash, certified check, cashier's check, bank draft or irrevocable letter of credit. Two percent (2%)
- 2) Bank Guarantee two percent (2%)
- 3) Surety Bond five percent (5%)

Bid opening shall be on 10:00am/**March 27, 2018** at **BAC Office Conference Room**. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

8.) The City Government of Tanauan reserved the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
